## Marvel Heath, A Life of Impact and Legacy

Service was a way of life for Marvel Heath. In fact, in 1996 she received Chaska community's highest service award, the George C. Klein "Service Above Self" Memorial Award, given by the Chaska Rotary. That "Service Above Self" attitude was demonstrated throughout her life, by her multitude of friendships, endeavors and accomplishments.

Somewhat early in her career, Marvel became the Assistant Dean of Women at St. Olaf College in Northfield, MN. While there she met Tom Heath who was here from Pennsylvania on a 1-year work project in Minneapolis, working for the Amidon Publishing Company. Of course, Tom never went back to Pennsylvania. They first met at a St. Olaf Christmas concert in December of 1968. They began dating after meeting again at the Moravian Church of Northfield in January of 1969, and were married in May that same year. Marvel and Tom were blessed by almost 46 years of marriage.

Marvel was an active member of the Eastern Carver County League of Women Voters for over 20 years. She was the co-chair of the Chaska Community Diversity Committee, creating a Human Rights Commission. She was a member of the School District 112 Curriculum Advisory Committee and at her Moravian Church of Chaska served on the Board of Elders, as Sunday school superintendent and as a counselor and youth leader. She served as board chair of the Interfaith Institute on Aging as well as serving on the Carver Senior Advisory Committee. She also was a member of the Community Sounding Board.

According to friends who served with Marvel, "She did not let you quit! Nothing was ever left half-done. You worked to find the solution and followed-thru."

Outside of her early career as a teacher, perhaps Marvel's most enduring legacy is the work and mission of Auburn Homes and Services. She began as the administrator/manager of the 22-bed Lake Auburn Home for the Aged, a Moravian Care Ministries service for retired pastors and missionaries on Lake Auburn, in Victoria. In 1982 she coordinated the planning and construction of Talheim Senior Apartments in Chaska. Marvel then began lobbying the state legislature on care options, specifically in order to obtain nursing home status for a facility in Chaska. In spite of a moratorium on all nursing home expansion at the time, she got her approval. She immediately began planning, fundraising, and eventually, supervision of the construction of Auburn Manor. The skilled nursing home facility opened in 1988.

# Creating a Legacy Through Planned Giving

Most of us want to know that we made a difference. We want to feel that our loved ones, other people, or organizations will be better because of our involvement.

There are many ways through which an individual, couple, or family can make a difference. One way is to support charitable organizations which have touched your life or have a mission in which you believe. Whether your gift will benefit the organization immediately or is a deferred gift, each gift will positively impact the organization and, more importantly, those who are served.

Charitable gifts help you meet both your current philanthropic goals and create your personal legacy well into the future. Planned gifts, specifically, provide creative and flexible strategies for your estate planning. But did you know that a planned gift can also protect your assets, provide for your loved ones, and guarantee you income for life?

The easiest and most direct way to make a deferred charitable gift is by bequest in a will. It requires only a short paragraph in the will that names the charitable beneficiary and states the amount of the gift. It may be a given amount or a percentage of the estate. At the time of the donor's death, the charity receives the gift and the donor's estate takes the income and estate tax deductions.

Life insurance is an excellent tool for making charitable gifts. It provides an "amplified" benefit far in excess of what would otherwise be possible. It may be in the form of a paid-up insurance policy, or may be structured so the annual premium payments can be deductible. The charity may be the primary or a contingency beneficiary.

Another way to make a planned gift is to create a charitable trust. There are many types of charitable trusts, the most common of which include a charitable remainder trust and the charitable lead trust. The remainder trust creates income for the donor or designated beneficiaries throughout their lives or for a given number of years, not to exceed 20 years. At the term of the trust, the remainder goes to the designated charity. The lead trust turns that arrangement around and provides income for the charity for a given number of years and the remainder then goes to the donor or designated beneficiaries. These trusts may be in the form of an annuity, which generates a given annual income for the life of the trust, or a unitrust, which generates a flexible income dependent on the annual evaluation of the trust.

These are just a few of the possible planned gifts you may consider. Charitable giving can play an important role in your estate planning. However, changes in tax laws and other considerations require extra planning and close attention to detail. You should talk with a qualified financial planner as you write or review your plans.
