Changes Come Over Time

Then in 1997 we introduced assisted living in Chaska and a few years later expanded the services provided to meet the growing demand of those with memory issues. In 2008 Auburn Home in Waconia opened, replacing a 70 plus year old skilled care facility in Waconia and bringing with it a new look and comfort to those we serve. Along with the new facility we dedicated a portion of the building to serve those that are in need of short term rehabilitative services. As these services grew we also identified that Waconia had additional needs in the community for assisted living and memory care. So in 2012 we opened, with great community support, Auburn Meadows Assisted Living and memory care.

Change is a continual reality, especially in our industry and Auburn Homes and services is working to embrace change so that those we serve receive the quality of care they have become accustom to. In 2015 we will be

changing our licensure in our home health services and developing a program to meet the ever growing demand of care outside of our assisted living facilities. It will provide another way in which we at Auburn can extend support to those in need in the community. Along with building new services we will begin the process of planning a remodel and new construction at our Chaska campus. The planning process will be over the next several years requiring many approvals from the state. Auburn's desire is that through our partnership with the City of Chaska and many others in the community, construction would begin in five to ten years.

Along with the bigger program changes there are several other smaller areas within the organization that are being reviewed and changed. As we move into the future we will continue to provide the quality of care for which we are known. Quality care that will bring comfort and compassion to the people we serve, delivered in a way that meets the challenges of what we face today and into the future.

The van enables us to offer complimentary, individualized transportation to our seniors to different locations within the City of Waconia (i.e. trips to the hospital or clinic). In the past, our residents would have relied on family members to provide this type of transportation or pay a fee from a local service provider. In this first year of operation, the program will focus on the Waconia community, with plans to expand the program to include all our facilities in the near future.

Due to the great response to the Fund-A-Need program, we have hired Kevin Meyer as our new transportation coordinator. He coordinates all transportation and drives both the van and bus. Thanks to the Fund-a-Need the first year of van operation is completely funded. Auburn Homes and Services has acquired all the licenses, fees and insurance, purchased a cell phone and I-pad for communication and coordination as well as funding for gas and repairs. The program will "kick-off" in March.

When Dick came to Auburn he was taken off the medications that had been sedating him, allowing him to come out of the fog he was experiencing and enabling him to become himself again. He has thrived at Auburn Meadows!

Dick is now doing things he has loved to do all his life. He is building things with his hands, something he had not done in years. Over the past two years, he has constructed four handcrafted wooden dollhouses, among many other projects. Two of his dollhouses were entered in the Carver County Fair and received first and second place ribbons.

One of his dollhouses was donated to the Belle Plaine Food Shelf and was auctioned at their benefit for \$625! This past Christmas season, the three remaining dollhouses were donated to the Southern Valley Alliance for Battered Women, through their Gifts for Hope Program. Company Matching Funds


As a 501(c)(3) organization under the Internal Revenue Code, Auburn Homes & Services is eligible to receive matching gifts from many companies. This gives many donors the opportunity to double or triple the size of their gifts to Auburn. As each company sets its own rules, eligibility varies. Typically, the donor completes an online or paper form provided by the company. The form is then directed to Auburn. Auburn completes the charity's section on the form and returns the form to the company. The company issues a check to Auburn according to its disbursement schedule. Auburn will designate the company's match to the same designation as the donor unless company rules provide otherwise.

Auburn Hosts Blood Drive with Special Significance

Auburn Homes and Services had already planned to host a blood drive in January. That is National Volunteer Blood Donor Month, chosen because it is the most challenging month to recruit people to give blood.

This year's drive, however, took on very special meaning when a personal need arose for the Auburn family. Natalie Eder serves as a Health Unit Coordinator at Auburn. Her 15-year-old son, Zack, was recently diagnosed with Ewing's Sarcoma Cancer. Zack will be undergoing a 6-week radiation program, has already received his first blood transfusion and will be in need of more transfusions in the future.

With the blood drive being dedicated to support Zack, our goal was to have 25 people donate blood at Auburn Meadows on January 21st. On that day, 24 people had pre-scheduled, 32 people presented to donate, and after a very busy day, 28 individuals donated blood in order to support Zach.
